WHAT DOES PAVILION PAYMENTS GAMING SERVICES, INC. DO WITH YOUR PERSONAL INFORMATION?

Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect, and share depend on the product or service you have with us. This information can include:

- Contact Information
- Social Security number
- Financial account information such as your checking account number
- Transaction history, payment history, account balances
- Credit history, credit score

How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Pavilion Payments Gaming Services chooses to share; and whether you can limit this sharing.

What we do

How does Pavilion Payments Gaming Services protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. We maintain physical, electronic and procedural safeguards to protect your personal information and limit access to personnel who have a need to access your information.

How does Pavilion Payments Gaming Services collect my personal information?

We collect your personal information, for example, when you

- give us your contact information
- show your government-issued ID or show your driver's license
- Open an account or update your account information
- When you engage in a transaction with us

We also collect your personal information from others, such as credit bureaus or other companies.

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes—information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

Definitions

Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- *Pavilion Payments Gaming Services affiliates include companies that share our name and those that are part of our corporate family, including Netspend Corporation.*

Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- *Pavilion Payments Gaming Services does not share information with nonaffiliates so they can market to you*

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- *Our joint marketing partners include other financial services companies*
